



40-YEAR PAINT WARRANTY FOR PARAMOUNT METALS (PM) STEEL PANELS

THIS WARRANTY COVERS SILICONIZED MODIFIED POLYESTER AND FLUOROPON MATERIAL ONLY

1. PM warrants that our panels will not crack, check, peel or lose adhesion, within a period of forty (40) years after the invoice date. This does NOT include minute fracturing, which may occur in proper fabrication of the building parts. Failure due to substrate corrosion is excluded. This warranty does not apply to the reverse side of our panels.
2. PM warrants that our painted roofing and siding panels will not, within a period of thirty years after installation or a period of thirty years and six months after the date of shipment (whichever comes first), chalk or lose color according to the following measurements. Chalk rating are measured in accordance with ASTM-D-4214-98 method D659. Color rating are measured in accordance with ASTM-D-2244-02. Color change shall be measured on the exposed painted surface that has been cleaned of dirt and chalk. It is understood that color fading may not be uniform if the surfaces are not equally exposed to the sun and elements.
 - a. Sidewall: Color 5 / Chalk 8 Exception: Brite Red: Color 8 / Chalk 6
 - b. Roof: Color 7 / Chalk Exception: Brite Red: Color 10 / Chalk 5
3. DISCLAIMER OF WARRANTY: THE EXPRESS WARRANTY STATED HEREIN IS THE EXCLUSIVE WARRANTY APPLICABLE TO PM PAINTED MATERIAL: PM MAKES NO WARRANTIES OR GUARANTEES, EITHER EXPRESSED OR IMPLIED, BEYOND THE FACE HEREOF INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. PM SHALL HAVE NO OTHER LIABILITY WITH RESPECT THERETO. This warranty will apply to those panels refinished or replaced but only for the period of time left on the original warranty. No employee or representative of PM is authorized to change this limited warranty in any way or grant any other warranty regarding our panels.
4. LIMITATION OF LIABILITY: THE EXCLUSIVE REMEDY FOR ANY AND ALL CLAIM ARISING FROM THIS LIFETIME LIMITED WARRANTY SHALL BE LIMITED TO PM REFINISHING OR REPLACING DEFECTIVE PANELS OR REFUNDING THE PURCHASE PRICE OF SUCH PANELS AS PM SHALL ELECT. PM SHALL NOT BE LIABLE FOR ANY LOSSES, DAMAGES, OR EXPENSES, WHETHER DIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES. IF OUR PANELS FAIL TO COMPLY WITH OUR LIMITED LIFETIME WARRANTY, WE WILL PAY FOR THE LABOR AND MATERIALS REASONABLY NECESSARY TO REPAINT, REPAIR OR REPLACE, AT OUR OPTION, THE BUILDING PART SHOWING THE FAILURE. PM'S TOTAL LIABILITY IS EXPRESSLY LIMITED TO THE PURCHASE PRICE OF THE PM STEEL PANELS.
5. Claims under this warranty must be made in writing to PM at the address on this limited lifetime warranty within 60 days after the discovery of the possible defect. Notice shall include identification of the material involved nature of the claimed defect, date of the installation, date of shipment, and work order number and a copy of your invoice before any action will be taken.
6. PM does not warranty or guarantee claims arising from damages due to exposure to salt and salt water, corrosive or harmful chemicals, airborne contaminants, hail or any other act of God.
7. PM does not warrant or guarantee claims arising from the following circumstances:
 - a. Acts of God, or any other acts such as fire that are beyond PM's control.
 - b. Minor hairline cracking of the paint finish.
 - c. Damage caused by handling, shipping, storage, or substrate failure.
 - d. Steel shaving or minute iron particles from sawing sparks that come in contact with the painted surface.
 - e. Red rust bleed through, from rust coming through cracks in the metallic substrate.
 - f. Non-vertical panels that don't have an adequate degree of pitch so as not to allow any free standing or accumulation of standing water.
 - g. Damage to panels caused by panel contact with fasteners.
 - h. Non-uniform weather conditions.
 - i. Harmful fumes from the environment or foreign substances in the atmosphere.
8. This warranty applies to panels installed only in the continental United States.
9. PM extends this warranty solely to the owner, at time of installation, of the structure where the material is originally installed. In instances where the owner of the structure where the material is installed is a non-living entity, including but not limited to corporation or associations, the warranty contained in paragraph 1 above is limited to 40-years.
10. THIS WARRANTY IS NOT TRANSFERABLE AND NON-ASSIGNABLE AFTER ONE YEAR FROM DATE OF INSTALLATION.
